## RELEASE AND WAIVER OF LIABILITY AGREEMENT

I AM USING THE INDUSTRIAL POWER SUPPLY IN AN INDUSTRIAL ENVIRONMENT WHERE MYSELF AND ANYONE ELSE USING THIS KNOWS AND USES APPROPRIATE SAFETY MEASURES FOR EXTREMELY HOT HIGH VOLTAGE EQUIPMENT.
